## CHAIRPERSON'S REPORT



The Board of Management wishes to congratulate our staff and volunteers on another successful year assisting people in the Moonee Valley community who otherwise would not have access to legal advice and related support services.

The performance of the service is measured through complex data. We are proud that our targets are always met or exceeded, in fulfilment of the requirements of Victorian Legal Aid (VLA), our main funding body. In addition, project funding has augmented our service delivery in the much needed area of family violence.

#### **Commonwealth funding**

We were delighted to learn that the decision by the Commonwealth government to reduce funding was reversed, partly in response to submissions and sector-wide advocacy that provided sound evidence of the impact these cuts would have on disadvantaged clients.

#### **Partners**

The Wingate Avenue Community Centre continues to be a key partner. We will continue to work together in the coming years to ensure our services are integrated into the new plans for the redevelopment of the Ascot Vale public housing estate.

Moonee Valley City Council continues to provide valuable support and networks for our service. This relationship is highly valued. We wish to thank Gadens for their pro bono support for our work with tenancy related issues.

Thanks also to our board member Marissa Dosen for arranging high quality and low cost training for staff at the offices of Holding Redlich.

The Flemington Kensington Community Legal Centre (FKCLC) continues to be our funded partner on projects including the Safe from Harm project and another which will explore unmet need and review the merits of various models of service.

#### **VLA Reform Steering Committee**

Over several months, I have represented our sector on a VLA Reform Steering Committee

which aims to improve the reporting, quality and accountability of service delivery through an "outcomes-based" approach. This initiative seeks to build the relationship between the funding body and services on the ground and strengthen the sector's capacity to target those most in need. The final report will be available by the end of the year.

#### **Ascot Vale Housing Estate Public Redevelopment**

The State Government has commenced consultation and planning for the Ascot Vale Public Housing estate to be demolished and rebuilt over a ten year period. Works will be undertaken in stages. Residents will be re-located for several years with the option to return. We are advised the project will increase social housing capacity by 10% and will include a mix of private and public housing. It will significantly improve the safety and quality of the lives of all residents.

The project will have considerable repercussions for the MVLS service and our service partners including Wingate Avenue Community Centre, Wingate Avenue Children's Co-Operative, the Maternal and Child Health Service, Settlement Worker, Financial Counsellor and Men's Shed.

The Board will continue to work with key stakeholders to ensure our services to the community are available in the long term and integrated into planning for ongoing services.

#### Summary

The continuity and quality of services to clients has been sustained through a year of staff changes and uncertainty of funding. The staff and volunteers have shown a willingness to work flexibly to respond to challenges and have maintained service efficiency, despite limited resources.

The MVLS is committed to extending our profile and service across the broader Moonee Valley catchment with outreach, Community Legal Education and partnering with services to better respond to unmet needs.

Finally we thank our funders and members for their support and commitment to our service.

#### **KEEPING FAMILIES SAFE FROM HARM**

Our Safe from Harm project addresses the unique barriers faced by CALD communities in the identification, reporting and prevention of family violence. The project employs two lawyers—one at MVLS and another at FKCLC — who provide culturally appropriate legal advice and assistance to persons affected by family violence. Since its inception in 2014 the project has worked with over 400 clients, and more than 800 community members and 300 community workers have been provided with information and legal education about family violence

This year, funding from the Department of Justice & Regulation facilitated the expansion of the project. We commenced family law outreach at Milleara Integrated Learning and Development Centre in Keilor East, complementing services and awareness raising activities at our own offices, local primary schools and community centres. With funding yet to be secured beyond 2017 we continue to seek financial support for the future of this valuable project.

#### SECURING HOUSING FOR OUR CLIENTS

Public housing tenants are some of Victoria's most vulnerable people, with eviction commonly leading to homelessness. With the assistance of Gadens, we provided advice and representation in tenancy related matters for public housing residents at both our Ascot Vale office and at an outreach at the Flemington Community Centre.

Common issues included extensive mould which was leading to health problems for the residents, urgent repairs of broken appliances including stoves and toilets, and rental arrears caused by erroneous calculations by the housing office.

With consultations and planning for the Public Housing Renewal underway at Flemington and Ascot Vale, we expect demand for this service to grow and we look forward to continuing our partnership with Gadens to provide tenants with timely and high quality legal advice.

#### USING INNOVATIVE TECHNOLOGY TO FIX FINES

In 2015 students from the RMIT Fastrack—Access to Justice Through Technology Challenge devised FineFixer, a web tool to help young people understand and pay their fines using a simple, quick and easy process. Enabling people to act earlier, preventing the accumulation of costs and penalties for people and freeing up valuable time for community legal centres and Victoria Legal Aid.

In 2016 the Moonee Valley Legal Service received a grant from the Victoria Law Foundation to build upon and expand the initial work of the students, turning the idea into the reality of FineFixer. FineFixer will be available to help anyone in Victoria to understand their fines and empower them to take action to resolve their fines problems.

#### **HELPING FAMILIES**

Our partnership with the Family Relationship Centre (FRC) Broadmeadows and Northern Community Legal Centre entered its seventh year. This initiative provides advice and support to families going through separation, assisting them to resolve their disputes, reduce hostility, and reach parenting agreements in relation to children.

Legally assisted mediation is vital in that it can narrow the issues for clients, while providing on the spot advice in complex family law matters. Further, it empowers clients where power imbalance exists and can resolve issues quickly.

This is an important partnership and one which we look forward to continuing.

### REPORT

The past financial year provided many opportunities and challenges for the Moonee Valley Legal Service. Throughout the year we delivered services at five locations across Moonee Valley. In partnership with Northern Community Legal Centre we also provided legally assisted dispute resolution at the Family Relationship Centre in Broadmeadows.

Strong relationships with stakeholders and partners are essential to our service. This year we commenced new partnerships with Gadens to deliver intensive tenancy casework and advocacy for public housing residents, and with local schools and community centres to ensure more people experiencing family law issues and family violence have safe access to legal advice and assistance.

Thanks to a grant from the Victoria Law Foundation we were able to commence work on FineFixer, a solution devised during the 2015 Access to Justice Through Technology Challenge at RMIT. We expect FineFixer to help thousands of people each year to understand their fines and take action to resolve their fines problems.

We hope that FineFixer will be the first in a long line of technological innovations to improve access to justice by MVLS, and we look forward to working with the wider legal assistance sector to develop a culture of innovation and risk-taking.

We have improved our outcomes measurement throughout 2016/2017 and will make further improvements in the coming years to ensure that we continue to provide an accountable, meaningful, and impactful service to our local community.

Co-location within the Wingate Avenue Community Centre remains a great strength of our service and we are proud to be part of this community.

This year we farewell our previous Principal Lawyer, Marguerite Bourke, our Manager Lauren Hills, and lawyers Liz Bitar and Tamara Kay. We thank these individuals for their dedication to the legal service over many years. Finally we would like to welcome our new lawyers Anita Khodher and Joe Ishow, and our new Manager Jacki Holland who recently returned to MVLS.

We are looking forward to the year ahead.



#### CASE STUDY 1 — Rahul\*

Rahul first came to see our family lawyer in 2016 after not having seen his two children for over a year. At the time Rahul's housing was precarious, he was at risk of homelessness, and he had accumulated a significant number of fines. Our lawyers worked closely with our social work student to address both Rahul's legal problems and housing issues. Thanks to the integrated intervention Rahul now has stable housing, regular access to his children, and is debt free. Rahul says he is much happier now and occasionally drops in to the legal service just to say hello.

#### CASE STUDY 2 — Julia\*

Julia had recently moved from interstate with her two children to escape her controlling and abusive husband. Julia needed to negotiate a division of superannuation with her ex-husband who had been the family 'breadwinner.' At the time, Julia was not receiving any child support or spousal maintenance contributions, and her only income was a disability support pension. Although we could not assist with court representation, we were able to support Julia to achieve a positive outcome for herself and her children. We assisted her to lodge court documents and provided advice to help her successfully obtain a settlement. As a result Julia can continue to support her children and protect them from family violence.

# TREASURER'S REPORT



The financial position of Moonee Valley Legal Service is sound with our results for the 2016/2017 financial year showing a surplus of \$32,658 (\$17,422 in 2015/16) and an accumulated surplus of \$145,023 (\$112,365 in 2016/17), MVLS is in a stable financial position and is well placed to remain so into the future.

The service faces the constant challenge of maintaining financial strength moving forward in an environment of limited funding resources. Traditional funding from State and Commonwealth Government grants are becoming more limited and restrictive with funding targeted at areas of particular legal need in the community. The core of funding remains from the Commonwealth Government and Victorian State Government totalling \$379,194 (62% of total income) for the year ending June 2017.

The remainder of funding accounted for grants, donations and other income totalling \$231,944 (\$171,206 in 2015/16). Victorian Legal Aid has confirmed the funding for 2017/18 and the revenue is forecasted to be in line with 2016/17 funding along with a 2% indexation.

Personnel costs for 2016/17 were \$401,854 (\$355,193 in 2015/16) and this accounts for 70% of total expenses. The personnel costs are being carefully monitored to enable and maintain our high level of client service.

During 2016/17 the service pursued various projects to strengthen its funding resources and scope of legal services. To be more sustainable the service needs to continue to seek out new funding sources additional to Commonwealth Government and Victorian State Government funding. I look forward to another successful year ahead which promises challenges and options for growth, and potential new project funding and partnership opportunities to assist us in extending our core business.

#### Report on the Audit of the Financial Report

#### **Opinion**

We have audited the financial report of Moonee Valley Legal Service Inc (the association), which comprises the Statement by Members of the Committee, Income and Expenditure Statement, Balance Sheet as at 30 June 2017, a summary of significant accounting policies and the certification by members of the committee on the annual statements giving a true and fair view of the financial position and performance of the association.

In our opinion, the accompanying financial report presents fairly, in all material respects, the financial position of the association as at 30 June 2017 and [of] its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the requirements of the Australian Charities and Not-for-profits Commission Act 2012 and the Associations Incorporation Reform Act 2012.

#### **Basis for Opinion**

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. #### **Emphasis of Matter - Basis of Accounting**

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of the Australian Charities and Not-for-profits commission Act 2012 and the Associations Incorporation Reform Act 2012. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

#### Responsibilities of the Committee for the Financial Report

Independent Auditor's Report to the Members

#### Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude on the appropriateness of the committee's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the association's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the association to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

We communicate with the committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
